1. Complete the form.
2. Attach a copy of the report for cabling the sewer line within the last 60 days.
3. Attach a copy of the paid real estate tax bill for the property.

Following receipt of this information, the Department of Public Works will review the application. The property owner must sign a Hold Harmless Release Form from the City prior to a city contractor doing any videotaping or repair work on the sewer lateral. The television inspector contractor will notify you by telephone to set up a date and time for the inspection. Following receipt and review of the television inspection, the City will send a letter to you advising you of the results of the investigation. If it is determined from the television inspection that the sewer is defective, the City's contractor will perform the necessary corrective work. The property owner will be responsible for 50% of all costs for the sewer lateral corrective work exceeding \$10,000.

HOLD HARMLESS RELEASE
