Important Information:

Contracts will be accepted on a first come, first served basis beginning March 1st at 8:30am. Contracts must be filled out at the time of registration. Proof of residency and proof of guardianship are required. Registration will not be taken/a spot will not be reserved if proper documentation is not presented. Child must be required age by the date listed for each program. **NO EXCEPTIONS** will be made. Age is calculated by the recreation software used by the City of Maryland Heights. As this is a nine month contracted program no new students will be accepted into the program after January 14, 2022.

Accepted proof of residency includes a valid photo ID and one of the following:

Current utility bill, Voter ID card, Current bank statement

Accepted proof of guardianship includes one of the following:

Birth Certificate, Passport, Insurance card with child's name, Social Security Card

Waitlist:

Due to the popularity of this program, classes fill very quickly. If a class is full you may elect to be put on a waitlist. All waitlist are first come, first served.

A waitlist DOES NOT GUARANTEE a spot in the program.

If you are on a waitlist you will only be contacted if a spot opens up in the class you are on the waitlist for. You will be contacted via the email address you have on file with the Parks and Recreation Department.

It is very important to keep your email address updated. You will have 48 hours to respond to the email. If you do not respond the next person on the waitlist will be contacted and you will be removed from the waitlist.

Payment:

We will be offering a member/resident rate and a non-resident rate. In order to be considered a member a child ages 4 and older or a parent of a child who is under 4 must have a annual membership . This is a nine month program and a contract must be on file. Your tuition will be divided into four payments. Payments will be due by **August 1, November 1, January 1 and March 1**. We will not be keeping a card on file. You will need to contact Tracey or stop by the welcome desk by the due date to make your payment. If your payment is late your child will **NOT** be able to attend classes until it is paid. No refunds will be issued for this program. If you need to cancel you must submit your request at least seven days prior to the next due date. Once a child has cancelled out of the program they can not reenroll.
